**Death Certificates:** A death certificate is a document used to record the vital statistics and cause of death for a deceased person. The original death certificate is kept on permanent file with the State Department of Vital. *Certified copies* of the death certificate are available to the public for \$20.00 per copy. These are official, colored legal documents and may be obtained through Funeral Alternatives, the county vital statistics office in which the death occurred, or the State Center for Vital Statistics. **Certified death certificates are usually required to make claims, transfer ownership, apply for benefits and for other legal purposes.**

**Social Security:** Funeral Alternatives will notify the Social Security Department as soon as they obtain the Social Security number of the deceased person. If there is a surviving spouse or dependent, the family must contact Social Security to apply for any benefits that are due.

Motor Vehicle Titles: Change the title for each vehicle, including boats:

Washington State Dept. of Licensing360-902-3770PO Box 9030Olympia, WA 98507You may need to fill out an Affidavit of Inheritance that is available through the Department.

The deceased's driver's license/identification is cancelled automatically through the Department of Health.

**Veterans Administration:** One certified death certificate is provided to the Veterans' Administration at no cost. On request, Funeral Alternatives will assist you with the paperwork for obtaining a U.S. Flag for ceremonial purposes, burial or inurnment in a National Cemetery, a veteran's marker, and possible private cemetery reimbursement.

## **Business and Financial Checklist**

- □ Obtain the Last Will and Testament
- □ Notify the deceased's attorney

Each item below "may" require separate certified death certificates depending upon specific requirements. When you contact them, be sure to ask if they will take a "copy" of the certified death certificate. Your funeral director will advise you how many certified copies to purchase (usually between one and four).

- Life Insurance
   Claim any available death benefits and fill out claim forms.
  Other Insurance: Auto, Home, Employee, and Medical
   Claim any available death benefits, fill out claim forms, and have deceased's name removed. May not need certified
   copy of death certificate.
  Stocks, Bonds, IRA, 401K, Annuities and Brokerage Firms
   Contact each company directly and follow their procedures.
  Banks and Credit Unions, Bank Accounts and Certificates of Deposit
   Some credit unions may have death benefits associated with membership.
  Employment and/or Retirement Pensions
   Some may have death benefits. Contact the Human Resources Department.
  Local and Out of State Real Estate and Property
   Contact the County Tax Assessor's Office for the area the property is located.
  Credit Card Companies, Bank Loans and Installment Contracts
   Some credit cards and loans may be insured with credit life. Be sure to check on this.
